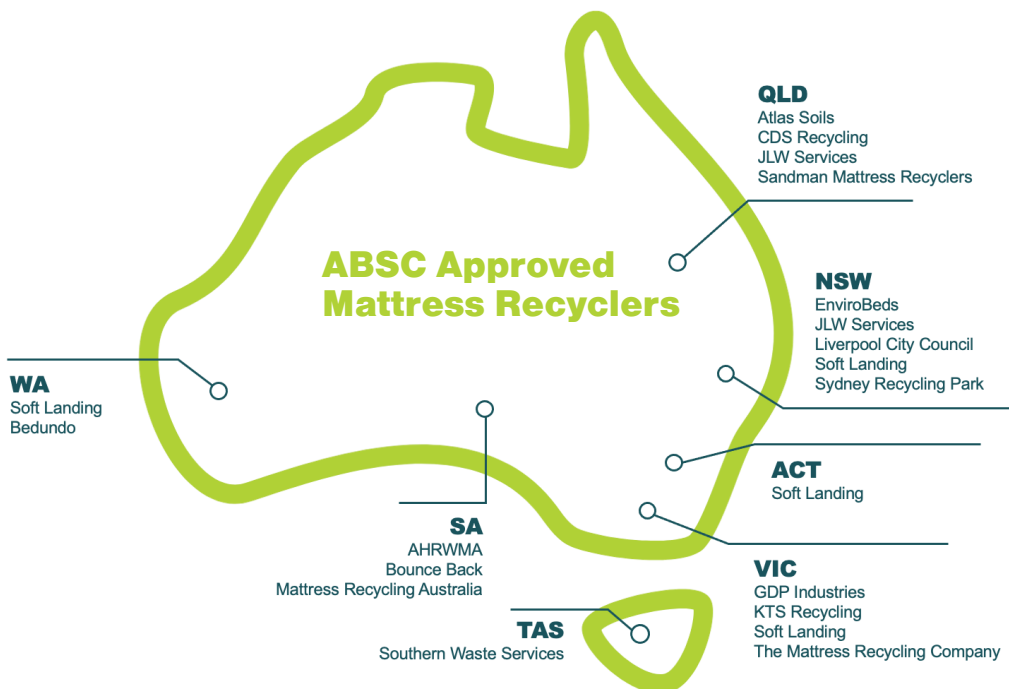

We have doubled the number of approved recyclers in FY25, extending the network of approved mattress recyclers to previous underserved areas like Tasmania, regional Western Australia, and Far North Queensland.
